These organisms were specially chosen to help aid in the breakdown of plant residue such as crop stubble, cover crops, and composts.

MIXING AND APPLICATION

Tank mix TerraTrove Residuce WS according to the directions in the table below. Mix only enough for the immediate application. Do not mix product with bactericides or copper compounds.

Liquid Solutions: it is recommended to mix TerraTrove Residuce WS with other products the day of use and to apply the product within 24 hours of wetting. Consult your sales representative for more specific rate recommendations.

Dry Blending: blend TerraTrove Residuce WS with the appropriate amount of dry fertilizer or solid material to cover the acreage you intend to treat.

Oraanic Grower Considerations:

This product is intended for use according to an approved organic system plan. Consult your organic certifier before using this product.
